



**A BAC RESOLUTION DECLARING TWO FAILED BIDDINGS  
AND RECOMMENDING FOR NEGOTIATED PROCUREMENT**

**RESOLUTION NO. 366, S. 2017  
(GOODS)**

**WHEREAS**, in compliance with the provisions of RA 9184, the Kalinga State University (KSU) published in the PhilGEPS website (<https://www.philgeps.gov.ph>) on June 29, 2017 to July 19, 2017 the Invitation to Bid (IB) for the conduct of public bidding for **Procurement of Coaster Vehicle (Ref. No. 264004080300004)** with an Approved Budget for the Contract (ABC) amounting to Four Million Philippine Pesos (Php 4,000,000.00) and posted the same at the KSU website (<http://ksu.edu.ph>), and conspicuous place at the premises of the University continuously for seven days;

**WHEREAS**, in response to the said advertisement, a bidder's representative from RDAK Transport Equipment Incorporated attended a Pre-bid Conference on July 7, 2017 but did not submit its proposals on July 19, 2017 Receipt and Opening of Bids, and the BAC declared a failure of bidding pursuant to Section 35.1(a) of the Revised IRR of RA 9184;

**WHEREAS**, upon request of the BAC, the TWG revised the terms, conditions and specifications in the Bidding Documents to attract prospective bidders;

**WHEREAS**, an IB for **Procurement of Coaster Vehicle** with the same ABC was re-advertised at the required sites on July 23, 2017 to August 1, 2017 which was responded by a bidder's representative of Golden Asia Automotive Corporation;

**WHEREAS**, during the Receipt and Opening of Bids held today - August 14, 2017, no bidders submitted their bids;

**NOW, THEREFORE**, We the members of the Bids and Awards Committee, exercising prudence, good faith and transparency, hereby **RESOLVE AS IT IS HEREBY RESOLVED:**

**to declare a second failure of bidding for the Procurement of Coaster Vehicle considering that there were no prospective bidders who submitted their bids after two publications pursuant to Section 35.1(a) of the Revised IRR of RA 9184;**

**to recommend a Negotiated Procurement under TWO FAILED BIDDINGS as provided by Section 53.1 of the 2016 IRR of R.A. 9184 for the above-mentioned project; and**

**to recommend for approval by the President of Kalinga State University of the foregoing findings.**

**RESOLVED FINALLY**, to post this Resolution at the KSU Website and conspicuous place at the premises of the University including the BAC Bulletin Board.
