A BAC RESOLUTION DECLARING A POST-QUALIFIED BIDDER AND RECOMMENDING FOR AWARD OF CONTRACT FOR THE COMPLETION OF TECHNOLOGY AND INNOVATION PARK-BULANAO CAMPUS PURSUANT TO THE REVISED 2016 IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

**BAC Resolution No. 012
 Series of 2023**

WHEREAS, in compliance with the provisions of RA 9184 and its 2016 Revised Implementing Rules and Regulations (R-IRR), the **Kalinga State University (KSU)** published the Invitation to Bid on the PhilGEPS Website (<https://notices.philgeps.gov.ph/>) from December 8, 2022, to December 15, 2022, for the bidding of **Completion of Technology and Innovation Park-Bulanao Campus** with an Approved Budget for the Contract (ABC) amounting to **Twenty-Four Million, Four Hundred Fifty-Seven Thousand, One Hundred Ninety-Five Philippine Pesos and Eighty-Three Centavos (Php 24,457,195.83)** sourced from Regular Agency Fund (RAF) Fund for CY 2023, and posted the same at the KSU Website (<https://ksu.edu.ph/>), and conspicuous place at the premises of the University Campuses continuously for seven (7) calendar days;

WHEREAS, in response to the said posting/advertisement, two (2) prospective bidders, namely: First Reliable Builders, and Supak C&M Construction Services browsed/read the opportunity at the sites mentioned above and downloaded the bidding document;

WHEREAS, the Bids and Awards Committee (BAC) and the Technical Working Group for Infrastructure Projects (TWG-Infra) conducted the Pre-bid Conference simultaneously via Google Meet Link: meet.google.com/pzn-abqv-zfn, with the bidder's representatives on December 16, 2022 @ 10 am whereupon Supplemental Bid/Bulletins (SBB) No. 01 dated December 21, 2022 was issued to amend the contents of bidding documents, particularly on the project requirements;

WHEREAS, only one (1) bidder, Teckcon Construction, purchased the bidding documents on December 20, 2022;

WHEREAS, during the **Submission and Receipt of Bids on December 28, 2022**, only Teckcon Construction, submitted its bid documents containing the technical and financial documents before the scheduled time;

WHEREAS, during the **Opening of Bids on the same day, December 28, 2022 @ 10:01 am**, the BAC, upon the recommendation of the TWG-Infra, declared the bids of Teckcon Construction as "eligible" and passed the technical evaluation of the bidding;

WHEREAS, the TWG-Infra recommended to the BAC, upon opening the Financial Bid Envelope, to declare the bids of Teckcon Construction as "complying", and further declared its as the Single Calculated Bid with a bid amount of Twenty-Four Million Four Hundred Forty-Five Thousand Four Hundred Ninety Seven Pesos and Eighty-Four Centavos (Php 24,445,497.84) subject to the conduct post-qualification evaluation;

WHEREAS, the TWG-Infra, upon the conduct of **Post-qualification Evaluation** by the Post Qual Team on January 6, 2023, recommended to the BAC to declare the bid of Teckcon Construction as the **Single Calculated and Responsive Bid (SCRB)**;

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee, upon recommendation of the Technical Working Group for Infra, **hereby recommends for approval by the Board of Regents through the University President to declare the bid of Teckcon Construction as Single Calculated and Responsive Bid (SCRB) and to award the contract amounting Twenty-Four Million, Four Hundred Forty-Five Thousand, Four Hundred Ninety-Seven Philippine Pesos and Eighty-Four Centavos (Php 24,445,497.84)** for the project: **Completion of Technology and Innovation Park-Bulanao Campus**.








Action of HOPE on BAC Recommendation through BAC Resolution No. 012, Series of 2023

By the power vested in me by the Kalinga State University Board of Regents, I hereby:

- APPROVE** the attached Resolution of the BAC based on the foregoing:
- Section 34.4, 2016 R-IRR of RA 9184: **Lowest Calculated and Responsive Bid (LCRB) or Highest Rated and Responsive Bid (HRRB).**
 - Section 36, 2016 R-IRR of RA 9184: **Single Calculated and Responsive Bid (SCRB) or Single Rated and Responsive Bid (SRRB).**
 - Annex "D," 2016 R-IRR of RA 9184: **Appropriate adjustments in the delivery of contract schedule, or contract price, or both, with modification of the contract.**

- Section 35.1(a), 2016 R-IRR of RA 9184: **No bids received.**
 - Section 35.1(b), 2016 R-IRR of RA 9184: **Bids received, but no one was eligible.**
 - Section 35.1(c), 2016 R-IRR of RA 9184: **All bids failed to post qualify.**
 - Section 35.1(d), 2016 R-IRR of RA 9184: **Someone post-qualified but refused without justifiable cause to accept the award.**
- SUBJECT FOR RE-BID** based on the following:
- Section 35.2, 2016 R-IRR of RA 9184: **Task the BAC and TWG to conduct a mandatory review and evaluation of the terms, conditions, specifications, and cost estimates in the bid documents.**
 - Section 35.3, 2016 R-IRR of RA 9184: **To task the BAC to conduct a re-bidding with re-advertisement and/or posting.**
 - Section 35.5, 2016 R-IRR of RA 9184: **To resort to negotiated procurement, specifically Two Failed Biddings (Sec. 53.1).**
