**A BAC RESOLUTION DECLARING C & E PUBLISHING, GREAT BOOKS TRADING,
AND ACADEMIC BOOK SALES AS POST-QUALIFIED AND RECOMMENDING FOR
AWARD FOR THE NEGOTIATED PROCUREMENT FOR PURCHASE OF VARIOUS
BOOKS AS COMPLIANCE TO KSU UNIVERSITIHOOD**

**RESOLUTION NO. 094, S. 2017
(GOODS)**

WHEREAS, in compliance with the provisions of RA 9184, the Kalinga State University advertised in the PhilGEPS and KSU websites and posted at BAC Bulletin Board, and conspicuous place at the premises of the University the Invitation to Bid for the hereunder Purchase Request continuously from November 10, 2016 to December 1, 2016 (1st bidding) and from December 12, 2016 to January 3, 2017 (2nd bidding):

WHEREAS, in consonance with Section 35.1(a) of the IRR of RA 9184, the BAC declared failure of biddings for both two postings due to absence of participating bidders, and published the same on January 22-25, 2017 using Negotiated Procurement under Two-Failed Biddings modality (Section 53.1, IRR of RA9184) after approval by the HOPE on January 4, 2017, the following 3rd posting:

WHEREAS, in response to the said advertisement, three (3) suppliers namely: C&E Publishing Incorporated, Great Books Trading, and Academic Books Sales Incorporated have submitted their quotations on January 25, 2017 and were opened on January 26, 2017 in accordance to the published Supplemental Bid;

WHEREAS, during the Opening and Evaluation of Bids, the BAC determined that said 3 bidders have complied with the submission of documents as required by 2-failed biddings negotiated procurement and proceeded with their per item bid evaluation and declared the 3 bidders that have the lowest calculated bids in applicable items, and the Summary of Bids as read are as follows:
