The filled-out and duly signed NNP must be submitted by the prospective external service provider/bidder together with the documents indicated in Annex B_Checklist for Eligibility, Technical and Financial Component.</li> <li>4. Bids received more than the ABC shall be automatically rejected at bid opening.</li> <li>5. The total price quoted is subject to withholding tax and payable checks.</li> <li>6. Each external provider shall submit <b>one (1)</b> original and <b>two (2)</b> copies of the first and second components of its bid with the following conditions: <ol style="list-style-type: none"> <li>a.
